Please follow the following instruction to make payment to your account held with *China Galaxy International Securities (Hong Kong) Co., Limited*:

- For deposits made via **online transfer** to any of the following banks: Standard Chartered Bank, Bank of China(Hong Kong), China Construction Bank (Asia), or ICBC (Asia) Limited, submission of a deposit proof is **not required**.
- For deposits made through **any other methods**, a deposit proof is **required**.

 - Please fill in **client’s account number** in the reference column while using the aforesaid banking services for payments.

Supporting document(s) should be provided by customers in order to verify the fund deposit and credit to client's account. Please refer to below table for the acceptable supporting document(s).

Cheque(to Cheque deposit machine)	Copy of Cheque(display the customer's name clearly) and Bank Transaction Advise (please select to print with cheque image)
Cheque(deposit from bank counter)	Copy of Cheque (the image must clearly show the customer's name) and deposit receipt (please fill in the customer's name and bank account number in the remarks of the receipt, and affix the bank's chop. If you forget to make a note or there is no bank chop, you must provide additional credit prove. Customers can also fill in their name and bank account number in the remarks of the receipt through their internal system through the bank relationship manager.)

☞ **If cannot provide valid deposit proof, needs our company to ask the bank for the proof of deposit entry. It will take about one to seven working days, and the relevant fees is HK\$100 must be borne by the customer.**

➤ **Fund Withdrawal**

For fund withdrawal, please contact Customer Service Officer or clients can also log in to the Online Trading Platform or China Galaxy International APP to submit withdrawal instructions (for Cash and Margin Accounts only). Fund Withdrawal should be made before **12:00p.m.** of Hong Kong local time, fund withdrawal instruction notified after the designated time will be processed in the next trade day.

With effect from 01 May 2026, HSBC will charge HKD 5 per deposited cheque. Please consult your bank for specific charge details.

Point to note:

Faster Payment System (FPS)	Same business day The maximum amount of each FPS transaction is \$1 million in HKD or RMB. For withdrawal amount over \$1 million, the withdrawal will be divided into several transactions according to the respective amount.	Free
Transfer/CHATS (for local)	Same business day	HKD150
Remittance (for oversea)	About one to two business day after Fund Withdrawal Instruction be notified (should according to Bank remittance processing time schedule)	HKD300
